

## FOREWORD

Developments in technology, the economic crisis that has marked recent history, evolutions in the professional sphere and the consequential demand for specialised workers have considerably changed the world of employment and its needs.

These evolutions have rendered the theme of “lifelong learning” ever more important. Article 4, paragraph 51 of Italian Law no. 92 of 28.06.2012 (“Regulations regarding reforms for the labour market with a view to growth”), also known as the Fornero Law, defines it as:

*“... any activity undertaken by people in a formal, non-formal or informal manner at various stages of their lives with a view to improving knowledge, ability and skill in personal, civil, social and employment terms [...], first and foremost with the identification and recognition of the cultural and professional wisdom acquired by citizens and workers during their personal and professional lives.”*

Seen in this light, lifelong learning is an opportunity to be guaranteed to everyone, adults as well as young people, at any stage of their lives, to constantly improve the skills and knowledge required by the labour market and for active participation in society.

Those looking to enter the world of employment, or for a new job, may need to acquire new skills or qualifications in order to gain a competitive advantage in the labour market.

Adults who already have a job may need to “go back to studying” and gain education in order to:

- gain qualifications of a higher level than the ones they already hold.
- increase their professional and technology skills, knowledge and abilities in order to respond to the demands of the labour market.
- train in order to acquire a new professional profile.

Those from foreign countries may need to learn Italian.

In order to provide a response to all these complex and varied demands, young people and adults in the province of Bergamo looking to recommence or continue their studies in order to gain qualifications have access to a range of opportunities.

A brief overview follows.



# INTRODUCTION

## THE EDUCATION AND TRAINING SYSTEM IN ITALY

The education and training system covers all levels of learning from early childhood to post-diploma and adult education.


Mandatory education lasts for 10 years, from the age of 6 to 16, and includes:

- 5 years of primary school.
- 3 years of lower secondary school.
- 2 years of upper secondary school, which can also be completed by attending regional Vocational Education and Training courses (IeFP).

In addition to mandatory education, all young people have the right/duty to education and training and to have access to educational activities until the age of 18. Students have access to a range of options for this right/duty:

- To continue their studies at upper secondary school or by attending a three-year vocational education and training course culminating in the obtaining of a minimum three-year qualification by the age of eighteen.
- To enter employment with an apprenticeship contract with the aim of gaining a vocational qualification.
- To attend an adult education course.

Below is a diagram to summarise the Italian education and training system.



Every year, the Provincia produces an updated version of the “Atlante delle scelte” guide, which is aimed at providing all the information necessary to allow students and families to choose their course of education and appropriate school after completing lower secondary school. The edition for the 2025-2026 school year, produced by Servizio Istruzione e Programmazione for the school network of the Provincia, provides detailed information on all the available opportunities and study paths in the Bergamo area: technical, vocational and general upper secondary education, as well as vocational education and training courses. # ADULT EDUCATION

## THE ADULT EDUCATION SYSTEM

The adult education system (IDA) covers all the educational activities aimed at the acquisition by adults of learning certificates, with a view to increasing the level of education of the general population and guaranteeing the right to learning at all stages of life.

This form of education is funded with public resources and is free of charge for participants. Adult education courses, including those held at correctional facilities, are organised by Centri provinciali per l'istruzione degli adulti as well as technical, vocational and general upper secondary institutes.

### **CPIA – CENTRI PROVINCIALI PER L'ISTRUZIONE DEGLI ADULTI (PROVINCIAL ADULT EDUCATION CENTRES)**

The CPIA, established with Italian Presidential Decree no. 263 of 29 October 2012, are independent educational institutes organised in local networks. They enjoy the same level of autonomy as schools, i.e., they have their own facilities, personnel and boards.

The CPIA offer programmes equivalent to mandatory basic education, as well as language courses for immigrants. The CPIA are able to provide:

- courses for the purpose of obtaining their diploma for the first cycle of education.
- courses for the purpose of obtaining certification of achievement of skills related to mandatory education.
- Italian language courses.

Furthermore, the CPIA may also expand their range of education options by organising, either independently or in collaboration with other institutional or non-institutional bodies, activities and/or courses to favour the improvement of basic skills such as IT, foreign languages and so on.

All the courses offered by the CPIA are flexible in nature, allowing personalised study programmes and the recognition of previous studies. Students may complete up to 20% of the overall hours of study through remote learning.

The CPIA are distributed throughout the province and are organised into "territorial service networks" structured on three levels:

- *Level A - Administrative Unit:* comprised of a central office and level-one study centres or associated facilities providing percorsi di primo livello and percorsi di alfabetizzazione.
- *Level B - Didactic Unit:* the CPIA liaise with upper secondary institutes, which provide percorsi di secondo livello.
- *Level C - Educational Unit:* the CPIA may extend the range of courses available through agreements with local organisations and other private or public organisations, in particular educational facilities accredited by the Regioni.



### 1. PERCORSI DI PRIMO LIVELLO

#### **What are these courses?**

These are courses for the purpose of obtaining certification of completion of the first cycle of education and certification relative to the basic skills acquired on completion of mandatory vocational and technical education.

The diploma, issued on completion of the percorso di primo livello, allows for enrolment in the percorsi di secondo livello, aimed at the obtaining of the upper secondary school diploma (diploma di Maturità – Upper Secondary School Diploma).

These courses are also of use in:

- requests for Italian citizenship.
- attending vocational training courses (Operatore Socio Sanitario - Healthcare Assistant, Estetista - Beautician, Cuoco - Cook...).
- setting up a business.
- completing mandatory education for minors.

#### **Who organises these courses?**

They are organised and delivered by the Centri Provinciali per l'Istruzione degli Adulti (CPIA).

#### **How do they work?**

The percorsi di primo livello are divided into two didactic stages:

- **THE FIRST DIDACTIC STAGE**, which ends with the earning of the diploma for completion of the first cycle of education (previously "licenza media").  
The overall duration of the courses is 400 hours. For students without a final primary school certificate, the overall duration can be increased by a maximum of 200 hours. This additional amount can also be used for the purposes of alfabetizzazione e apprendimento della lingua italiana (literacy and Italian language studies).  
The courses include modules for Italian, English, maths, technology and IT, natural sciences and social studies.  
Certificates are issued on passing the final State exams for completion of the first cycle of education. Students are required to attend at least 70% of the overall number of hours provided for by the individual education pact in order to be allowed to sit the final exams.
- The purpose of the **SECOND DIDACTIC STAGE** is to bolster basic skills and terminates with the acquisition of certification of the basic skills related to mandatory education pursuant to Italian Ministerial Decree 139/2007. This stage is required for access to upper secondary school (evening courses).

The overall duration is 825 hours, and culminates (with attendance of at least 70% of the overall number of hours) with the issuing of the relative certification of the skills acquired.

### **Who are these courses for?**

- Adults, including foreigners, who have not completed mandatory education or who do not have a diploma for completion of the first cycle of education.
- Adolescents who have reached the age of sixteen and who do not have a diploma for completion of the first cycle of education.
- Foreign adults of employment age, including those with a diploma earned in their country of origin, seeking to attend Italian language courses.

The percorsi di primo livello can also be held at correctional facilities for adult inmates.

### **How to enrol**

Anyone intending to enrol in the percorsi di primo livello, generally in the period from May to October, should present an application for enrolment directly at the offices of the administrative unit of their relative CPIA, via “associated facilities” if necessary.

Applications can also be made online, and in these cases, for the province of Bergamo, applicants should fill in the enrolment form available via the following links:

## 2. PERCORSI DI SECONDO LIVELLO (EVENING COURSES)

### **What are these courses?**

These are study courses held during the evening and aimed at the attainment of an upper secondary school diploma (technical, vocational and general upper secondary school diploma).

Evening courses are equivalent to traditional daytime courses in terms of value. The only differences are the lesson times and the requirements for access.

In particular, this type of course is aimed at permitting:

- additional professional development for adults who are already working and who are looking to further their careers.
- return to study for both students who previously dropped out of school and for those looking to continue their studies, for example at university, with specialisation, etc.
- foreigners to obtain a diploma in Italy.

### **Who organises these courses?**

They are organised by technical, vocational and general upper secondary institutes that also organise daytime courses, in collaboration with the CPIA.

Not all educational institutes that organise daytime courses offer corresponding evening courses, and it is therefore necessary to refer to the courses approved annually by the Regione Lombardia when making choices regarding study.

### **How do they work?**

They are organised in three didactic stages, and can take place over either 3 or 5 years:

- **FIRST DIDACTIC STAGE** (1st and 2nd years), aimed at the acquisition of the certificate for the first two years of general, technical or vocational education required to access the second two years of courses at technical or vocational institutes, in accordance with the study path chosen by the student. This stage also qualifies for compliance with mandatory education and with the right and duty to education and training (DDIF).
- **SECOND DIDACTIC STAGE** (3rd and 4th years), aimed at the acquisition of the certificate for the second two years of general, technical or vocational education, for the acquisition of a vocational qualification, and to access the final year of courses at technical or vocational institutes, in accordance with the study path chosen by the student.
- **THIRD DIDACTIC STAGE** (5th year), aimed at the acquisition of a technical, vocational or general upper secondary school diploma in accordance with the study path chosen by the student. The third didactic stage ends with a State exam for the issuing of the diploma relative to the chosen study path.

Each didactic stage has an overall duration of 70% of the duration of the corresponding daytime courses. These school courses are therefore shorter. Furthermore, in order to render the hours of attendance required sustainable for students, it is possible to have previously acquired education credits (for example for total or partial attendance of other courses, professional activities carried out, etc.) recognised. This allows students to enrol in courses without beginning with the first class and/or to not attend all of the subjects provided for.

School credits are recognised for:

- professional activities in line with the relative school course studied.

- vocational training certificates.
- self-training courses.

In addition to courses for the acquisition of upper secondary school diplomas (general, technical and vocational), some schools also organise three-year evening courses for Vocational Education and Training (IeFP). Education credits can also be recognised for these courses, allowing the number of hours of study to be reduced by up to 50% of the overall duration of the course.

Evening course lessons are free of charge.

The school year begins in September/October and ends in June. The courses generally take place in late afternoon/evening, and some institutes also schedule courses in the afternoon. At the end of the courses for general, technical and vocational education, students sit state exams for the acquisition of the final diploma, which allows them to:

- directly enter the labour market.
- continue their studies:
  - at university.
  - at higher art, music and dance education institutes.
  - at higher technical institutes.
  - with higher technical education and training.
- in the case of technical and vocational diplomas, continue with study and professional paths required for registration in professional associations.

Students also sit an exam at the end of vocational education and training courses in order to acquire a level-three vocational EQF certificate or a level-four vocational EQF diploma. These qualifications allow students to:

- enter the labour market.
- for holders of a vocational diploma:
  - continue their studies in the vocational education system with a view to obtaining an upper secondary school diploma subject to verification by the school institute of the student's level of education in order to ensure they are placed in a suitable class.
  - continue with higher technical education and training (IFTS) courses.

### **Who are these courses for?**

- Adults, including foreigners, over 18 years of age, with a lower secondary school diploma.
- Adolescents who have reached the age of 16 who have a diploma for completion of the first cycle of education and who can prove that they are unable to attend a daytime course.

The percorsi di secondo livello can also be held at correctional facilities for adult inmates. Anyone who already has a secondary school diploma, including those issued in another country, or who has interrupted their studies, can present their school reports for the purpose of assessment of acceptable school credits.

## FURTHER INFORMATION

### **Recognition of foreign study diplomas**

Foreign study diplomas have no legal value in Italy, and it is therefore necessary to request that said diplomas be recognised in order to be able to carry out professional activities, take part in a competition or continue with studies. Equipollence is a process in which a diploma (either a lower or upper secondary school diploma) obtained abroad is declared to correspond to a specific qualification obtainable in Italy.

*N.B. Declarations of equipollence are only issued for the aforementioned diplomas and not for degrees, which are the responsibility of universities in accordance with individual methods.*

The recognition of qualifications is increasingly in demand, and is closely related to the phenomena of mobility and relocation of people.

In Italy, procedures for recognition can prove to be extremely articulated and complex, as they change on the basis of a number of variables.

According to current legislation (Italian Legislative Decree no. 297/94 art. 379 as amended by art. 13 of Italian Law no. 29 of 25 January 2006), declarations of equipollence may be obtained by citizens of Member States of the European Union, of Member States of the European Economic Area Agreement and of the Swiss Confederation who are at least 18 years of age (exclusively for applicants for equipollence with the upper secondary school diploma).

*N.B. Declarations of equipollence are not available for non-EU citizens.*

Applications for the issuing of a declaration of equipollence may be made:

- with the Ufficio Scolastico Provinciale of the province of residence for lower secondary school diplomas.
- with any Ufficio Scolastico Provinciale for upper secondary school diplomas.

### **How to enrol**

Enrolments generally take place in the period from May to October and are made directly with the school offering the relative evening course and on the basis of the indications defined every year with a dedicated memorandum from the Ministry of Education.

### **3. PERCORSI DI ALFABETIZZAZIONE E APPRENDIMENTO DELLA LINGUA ITALIANA**

#### ***What are these courses?***

These courses are aimed at foreign adults for the purpose of obtaining certification of knowledge of Italian at a level of at least Common European Framework of Reference for Languages (CEFR) level A2.

The level A2 courses organised by the Centri Provinciali per l'Istruzione degli Adulti (CPIA) are the only courses to be recognised by the Ministry of the Interior for the purposes of granting a long-term EC permit of stay. Since 09/12/2010, anyone requesting an EC permit of stay must have passed an Italian language test.

In addition, 10/03/2012 marked the implementation of the Integration Agreement which, among the commitments to be assumed by a foreign citizen, includes the acquisition of a knowledge of Italian at level A2, i.e., a medium-good level of Italian that allows the speaker to ask for information, present themselves and fill in a form with their personal information.

#### ***Who organises these courses?***

They are organised and provided by the CPIA, which may also provide preparatory and higher-level Italian language courses.

#### ***How do they work?***

The percorsi di alfabetizzazione have a maximum duration of 200 hours, and study groups are organised by level.

Additional modules are available for strengthening, increasing and improving skills.

At the end of the courses, once achievement of the relative level has been ascertained, a certificate of knowledge of Italian at level A2 is issued.

#### ***Who are these courses for?***

- Foreign adults of employment age, including those with qualifications earned in their country of origin.

#### ***How to enrol***

Those intending to enrol in percorsi di alfabetizzazione e apprendimento della lingua italiana (Italian literacy and language courses) should apply directly to their relative CPIA administrative unit, also via "associated facilities".

## **4. PERCORSI DIDATTICI DI AMPLIAMENTO DELL'OFFERTA FORMATIVA - PERCORSI DI GARANZIA DELLE COMPETENZE**

### ***What are these courses?***

In addition to the standard courses, the Centri Provinciali per l'Istruzione degli Adulti (CPIA) also organise courses for the development of key citizenship competence skills as defined by the European Union. The courses are provided either autonomously or in collaboration with other subjects, and take into account the cultural, social and economic context of local organisations. The aim is to supplement and enrich adult education courses and to favour the development of skills among the adult population.

The following, in particular, are organised:

- Courses for the development of digital skills (with reference to DigComp)
- Courses for the development of foreign language skills (with reference to the CEFR)
- Courses for the development of Italian language skills at level B1 (with reference to the CEFR)

### ***Who organises these courses?***

The courses are organised and delivered by the CPIA.

### ***How do they work?***

The courses are organised on the basis of requests for enrolment at the various branches of the CPIA. Students are divided into level groups on the basis of entry tests.

At the end of the courses, certificates are issued for attendance (for basic courses) and knowledge (for intermediate and advanced courses).

### ***Who are these courses for?***

- Anyone of at least 16 years of age, including non-Italian citizens.

### ***How to enrol***

Anyone intending to enrol in the Percorsi di Garanzia delle Competenze must apply directly to the CPIA associated facilities.

## POST-DIPLOMA EDUCATION AND TRAINING

After having earned the upper secondary school or vocational diploma, it is important for those intending to continue their studies to be able to navigate the complex system of post-diploma options.

The aim of this part of the guide is to offer some basic information on the possible alternatives.

### **IFTS – Higher Technical Education and Training**

#### ***What are these courses?***

These are free annual courses aimed at educating students to a level of vocational post-secondary competence, at which point they are defined as Specialised Technicians and are qualified to respond to the demands of the public and private employment market.

#### ***Who organises these courses?***

They are organised by groups of entities from education, vocational education and training, vocational training, university and professional systems. IFTS courses can also be organised by ITS Academy Foundations.

#### ***How do they work?***

The courses cover two semesters: 800/1000 hours of practical and workshop activities as well as theory.

One mandatory requirement is that at least 30% of the overall course hours must be in a company (either through internships either in Italy or abroad, or with employment through an apprentice contract).

Attendance is obligatory.

The qualification issued at the end of the course is the Certificate of Higher Technical Specialisation (EQF level IV), which allows access to ITS courses.

#### ***Who are these courses for?***

Unemployed young people and adults with:

- an upper secondary school diploma.
- a technical vocational diploma earned through IeFP courses.

### **ITS ACADEMY – Higher Technical Education**

#### ***What are these courses?***

These are highly specialised technical courses that offer an alternative to university, and that focus on professional sectors and figures considered to play a strategic role in industrial and technological development, as well as in rendering the Italian manufacturing sector competitive.

ITS courses respond to the demand from companies for the professional figures that play an essential role in promoting and maintaining processes of innovation, and allow the acquisition of the knowledge, abilities and skills required to operate in technologically advanced fields.

### **Who organises these courses?**

The courses are organised by ITS Academy Foundations composed of school and training institutes, businesses, universities, research centres and local authorities, who work together to plan the education courses.

### **How do they work?**

The courses last for two years and are generally organised over four semesters (minimum 1,800 hours). For particular professional figures requiring a high number of hours of in-company work experience, courses lasting for six semesters (minimum 3,000 hours) may be organised.

At least 35% of the overall course hours are spent in companies, and periods of work experience may also be organised abroad.

At the end of the course, and after having passed the final tests, the following qualifications are issued:

- For courses of a duration of 4 semesters, a Diploma of specialisation in applied technologies, which certifies the acquisition of skills in line with EQF level V.
- For courses of a duration of 6 semesters, a Diploma of higher specialisation in applied technologies, which certifies the acquisition of skills in line with EQF level VI.

Both qualifications are valid throughout Italy and recognised on a European level.

At least 80% attendance is obligatory.

### **Who are these courses for?**

Young people and adults with:

- an upper secondary school diploma.
- a vocational diploma (fourth year) earned on completion of four-year courses in IeFP (Vocational Education and Training) followed by IFTS (Higher Technical Education and Training) Certification.

Good knowledge of English and IT is preferential for admission to these courses.


## **UNIVERSITY EDUCATION**

The Italian university sector is composed of Higher Education Institutes divided into:

- state universities.
- legally recognised non-state universities.
- legally recognised non-state remote universities.
- specialised higher education schools or institutes.

The legally valid qualifications are issued by Institutions authorised and accredited by the [Ministero dell'Università e della Ricerca](#).

The university system in Italy is organised in three cycles: the main qualifications in Italy are the Laurea (1° ciclo) – Bachelor's degree (1st cycle), the Laurea magistrale (2° ciclo) – Master's Degree (2nd cycle), and the Dottorato di ricerca (3° ciclo) – Research Doctorate (3rd cycle), in addition to other academic courses and relative qualifications.



## 1st cycle

### **BACHELOR'S DEGREE** (3 years)

Aim: to provide suitable proficiency in general scientific methodology and content.

CFU (Crediti Formativi Universitari – University Education Credits): 180 CFU.

Criteria for access: an upper secondary school diploma or other qualification earned abroad and recognised as suitable.

## 2nd cycle

- **MASTER'S DEGREE** (2 years)

Aim: to provide an advanced level of education for the carrying out of highly qualified activities in specific fields.

CFU (Crediti Formativi Universitari – University Education Credits): 120 CFU.

Criteria for access: a degree or other academic qualification earned abroad and recognised as suitable.

- **SINGLE-CYCLE MASTER'S DEGREE COURSE** (5 or 6 years)

Aim: to provide an advanced level of education for the carrying out of highly qualified activities in specific fields governed by European directives (Medicina e Chirurgia – Medicine and Surgery, Odontoiatria e protesi dentaria – Dentistry and Dental Prosthesis, Medicina veterinaria – Veterinary Medicine, Farmacia – Pharmacy, Chimica e tecnologie

farmaceutiche - Pharmaceutical Chemistry and Technology, Architettura e Ingegneria civile-architettura - Architecture and Construction Engineering-Architecture) or for access to legal professions (Giurisprudenza - Law) or to other professions governed by national legislation (Scienze della formazione primaria - Primary Teacher Education, Conservazione e restauro dei beni culturali - Conservation and Restoration of Cultural Heritage).

CFU (Crediti Formativi Universitari - University Education Credits): 300 (5 years) - 360 (6 years).

Criteria for access: an upper secondary school diploma or a qualification earned abroad and recognised as suitable. Access may be subject to an admissions test.

- **LEVEL 1 UNIVERSITY MASTER'S COURSE** (1 year)

Aim: to provide an opportunity for advanced scientific or higher on-going education to complete a corresponding course of studies.

CFU (Crediti Formativi Universitari - University Education Credits): 60 CFU.

Criteria for access: a degree or other academic qualification earned abroad and considered as suitable.

Admission may be subject to further requirements.

### 3rd cycle

- **RESEARCH DOCTORATE** (3 years)

Aim: to provide the skills required to carry out highly qualified research in the scientific or manufacturing fields.

Criteria for access: a Specialised/Master's degree obtained in Italy or abroad. Admission exams are required.

- **LEVEL 2 UNIVERSITY MASTER'S COURSE** (1 year)

Aim: advanced university education.

CFU (Crediti Formativi Universitari - University Education Credits) acquired: at least 60 CFU.

Criteria for access: a bachelor's degree or master's degree.

- **DIPLOMA OF SPECIALISATION COURSE** (2 - 6 years)

Aim: to provide knowledge and abilities for functions required in the carrying out of particular professional activities.

Criteria for access: a master's degree and the passing of a public competition.

## **AFAM – Higher Level Arts, Music and Dance Education**

The system of Higher Level Arts, Music and Dance Education (AFAM) is comprised of Italian arts and musical institutes recognised by the [Ministero dell'Università e della Ricerca](#). These include the Academies of Fine Arts (state and legally recognised institutes), the National Dance Academy, the National Academy of Dramatic Arts, the ISIA (Higher Schools for Art Industries), and the Conservatories and Higher Schools for Musical Studies.

These are institutes that carry out training, production and research activities in a range of sectors of the arts: visual arts, musical arts, scenography, dance, theatre, entertainment and design.

As with the Italian university system, the AFAM system is organised in three cycles, to which specific study courses correspond according to distinct educational goals, criteria for access, duration, methods for the acquisition of academic education credits and end-of-course qualifications.

The qualifications issued are considered to be equipollent, therefore equivalent to university qualifications.

Tests may be required in order to access courses, as many have limited places. It is necessary to verify the method of access and the attendance requirements for each specific course.

## ON-GOING EDUCATION

For adults looking to further their education and obtain vocational skills of value in the labour market, the Lombardy region offers a wide range of opportunities.

The range of opportunities available depends on a number of elements:

- Whether the course is recognised or not by the Regione Lombardia.
- The state of employment of the applicant (employed or unemployed).
- The qualifications required for access.
- The certification issued at the end of the course.
- The cost of the course (or whether it is free of charge).

The courses available:

- are for adult students.
- are aimed at obtaining vocational skills of practical value in the labour market.
- are aimed at facilitating those who have left the labour market in returning to work.
- are aimed at favouring professional growth and development for those who already work, with a view to lifelong learning.

The courses are provided by organisations accredited by the Regione Lombardia.

## EMPLOYMENT AND ORIENTATION SERVICES

In order to receive information regarding the search for work and/or an educational course and to access the various opportunities presented in this guide, there are a number of public and private services available within the province, including the Centri per l'impiego and Informagiovani.

### CENTRI PER L'IMPIEGO

#### **What are these centres?**

The Centri per l'impiego (Cpi) are public offices accredited to provide qualified employment-related services free of charge. Citizens may contact these centres when looking for a job, to take part in active regional and national policies, and to obtain the documentation required for the acquisition of "unemployed status".

#### **Who manages these centres?**

The Centri per l'impiego (Cpi) are managed by the Provincia di Bergamo.

#### **What services do they offer?**

  - Introduction to vocational training and requalification (in collaboration with accredited training entities)
  - Introduction to selection within Public Administration for roles and functions that only require completion of mandatory education
  - Consultancy regarding EURES network services for those seeking employment in Europe
  - Information and support regarding self-employment
- SERVICES FOR COMPANIES:
  - Information regarding incentives, employment benefits and active employment policies
  - Compliance with the Comunicazioni obbligatorie delle imprese (COB)
  - Bringing together job seekers and offers, publication of announcements and pre-selection of candidates
  - Organisation of extra-curricular internships
  - Access to the national and regional Dote\* system

- Enrolment for targeted placement for disabled people and protected categories at Cpi



## **INFORMAGIOVANI**

### ***What are they?***

Informagiovani are information and orientation services for pre-adolescents, adolescents and young people. Their goal is to assist and support choices made regarding future school, training and professional careers, as well as to provide information on opportunities for volunteering, international mobility and active citizenship.

### ***Who manages these centres?***

These are public services, generally run on a municipal, provincial or territorial level, managed by qualified personnel within said organisations or from the tertiary sector. The staff is composed of experts in information and orientation processes, educational and orientation advice, social innovation and the local labour market, communication and social media. Each professional figure plays a specific role in the organisation and management of the projects implemented.

### ***How do they operate?***

It is fundamental for Informagiovani to create networks within the territory in order to be able to efficiently work with lower and upper secondary schools, training institutes, employment agencies, voluntary associations and entities and all the other organisations that, in some manner, contribute to and favour the choices made by adolescents and young people. As well as families and young people the Informagiovani also meet with teachers, educators and other relative adult figures who play an active role in creating future plans for new generations.

### ***The Informagiovani network in Bergamo***

There are a number of Informagiovani operating within the province of Bergamo that collaborate to achieve various goals with an ever-broader view to creating connections and to shared planning.
